

# **Earthquake Safety and Public Buildings Rehabilitation Bond Act of 1990**

## **Local Government Buildings Bond Act Expenditures**

**Status Report  
December 2006**

Department of General Services

## **Program Status**

The Department of General Services (DGS) is issuing this report to the Legislature pursuant to the requirements outlined in Government Code Section 8878.97. The program is pleased to report that as of December 1, 2006, 99.6 percent of the program funds have been committed. Of the 167 projects initiated, 121 projects are complete, three projects are in process, 14 projects have been cancelled because funding was not re-appropriated by the Legislature, and 29 projects have been withdrawn by local agencies.

## **Background**

Under the Earthquake Safety and Public Buildings Rehabilitation Bond Act of 1990, voters approved bonds to be sold in the amount of \$300 million, of which \$50 million was for seismic retrofitting of local government essential services and public safety buildings. Approximately \$4.08 million was set aside for support; and \$500,000 was allocated to Riverside County per the provisions of SB 248 (Chapter 332, Statutes of 1993).

Phase I (1994) appropriated \$45,478,621 of the \$50 million for 113 seismic retrofit projects.

Phase II (1997) was comprised of 54 projects totaling \$8,785,566. (The first 27 were funded in 97/98 FY, 20 in 98/99 FY, the next seven in 99/00 FY).

Revised reappropriations in the 1996, 1997, 1998, 1999, and 2000 Budget Acts, have resulted in a reversion of \$3,427,205. There were no revised reappropriations in 2001, 2002, 2003, 2004, and 2005. Funds for three projects, which had expired on June 30, 2004, were reinstated on July 1, 2005.

To date, 43 projects have been withdrawn (\$3,642,296 reverted); and the 121 completed projects have produced surplus money (\$2,018,388 reverted).

Therefore, the adjusted total appropriation is \$45,176,298, with an approximate fund balance of \$215,289.

## **Project List**

This local government grant status report was prepared with data available as of December 1, 2006. The 167 projects are outlined in this report as follows:

First: Projects in the same order as listed in the 05/06 Budget Act (three projects).

Second: Projects complete (121 projects).

Third: Projects that were withdrawn (43 projects).

The dollar amounts approved in the Budget Act for each project are predicated upon preliminary estimates furnished by local governments. Once the local jurisdiction receives bids for the project, the grant is written for the lesser of either the estimate or the actual bid amount. On December 1, 2006, the DGS' Real Estate Services Division (RESD) requested that local governments furnish a current project schedule that included bid, award, construction start, and construction finish dates. We requested justifications for any delays from those local governments which indicated that they would start construction after the June 30, 2007, deadline.

Following is an explanation of the headings on the project list:

1. Project - The name of the project; the address and use of structure; the name of the project manager for the local government, and phone number and FAX, if known.
2. Total Appropriation - The total Budget Act dollar amount.
3. Grant Amount - The dollar amount of either the actual construction bid or Budget Act amount, whichever is less.
4. Comments - Additional relevant items related to project progress, including any justification the local government has given for delays. Where this column is blank, no information has been received.

- Project Cancelled: Funding not reappropriated in the Budget Act.
- Grant Completed: Project is complete. All grant money has been paid to applicant. Grant is closed out.
