**RE: Launch of the State Contract and Procurement Registration System (SCPRS)
Dashboards Website**

The purpose of this Broadcast Bulletin is to inform state agencies and interested stakeholders of the launch of the Procurement Division's (PD) eProcurement Business Intelligence Strategies Section (eBISS) SCPRS Dashboards Website.

The DGS Procurement Division eBISS is leveraging the statewide SCPRS data to show trends in how the State of California purchases goods and services. By leveraging SCPRS data, PD is able to offer statewide procurement data dashboards that will serve as a powerful tool for departments and suppliers alike.

The following data dashboards are available:

- **Statewide Procurement Data Dashboard**

This dashboard offers state contract and procurement information, which highlights specific data related to Small Business and Disabled Veteran Business Enterprise (SB/DVBE) certified supplier awards.

This dashboard provides answers to the following questions:

- What was the overall dollar sum that was awarded to certified SB/DVBE suppliers in a given fiscal year?
- What Number of Departments made awards to certified SB/DVBE suppliers in a given fiscal year?

- What were the top 30 United Nations Standard Products and Services Code (UNSPSC) commodities or services procured by the state in a given fiscal year?
- Who were the top 30 awarded certified SB/DVBE suppliers in a given fiscal year?
- **Statewide SB/DVBE Procurement Data Dashboard**

This dashboard previews what the state currently procures from certified SB/DVBE suppliers by using the UNSPSC. This tool helps departments, suppliers and the public easily identify potential opportunities, which improves contracting participation by state certified SB/DVBE suppliers.

This dashboard includes funds that are excluded from the Consolidated Annual Report (CAR), and answers the following questions:

- What sum (dollars) do Departments award to certified SB/DVBE suppliers vs. non-certified SB/DVBE suppliers in a given fiscal year?
- What are the Top 10 UNSPSC categories that are awarded(dollars) to non-certified SB/DVBE suppliers in a given fiscal year that could potentially be considered opportunities for SB/DVBE certified suppliers?
- How many certified SB/DVBE suppliers were previously awarded a UNSPSC category that was also awarded to a non-certified supplier?
- How many certified SB/DVBE suppliers in the certification database have a UNSPSC category identified in their profile?
