## **Purpose**

The purpose of this memo is to provide information on the General Salary Increase (GSI) and Other Post-Employment Benefits (OPEB) for excluded and exempt employees.

# **General Salary Increase**

Effective July 1, 2019 excluded employees with a Collective Bargaining Identifier (CBID) of "C", "S" or "M" will receive the same general salary increase as the bargaining unit they are tied to. For example, employees with a CBID of S12 or M12 will receive the same three and one half percent (3.5%) GSI R12 employees will receive on July 1, 2019. Please refer to chart below:

Exempt and excluded employees not directly tied to a bargaining unit, such as many of the employees who have an "E" CBID will receive a GSI of 3.5 percent effective July 1, 2019.

\*Bargaining Units 2, 7, and 13 are not scheduled to receive a GSI, and therefore, exempt and excluded employees tied to these bargaining units will not receive a GSI on July 1, 2019. Updates will be communicated in a future memo as the bargaining is ratified.

## Other Post-Employment Benefits (OPEB)

Effective July 1, 2019, exempt and excluded employees not directly tied to a bargaining unit, such as many of the employees who have an "E" CBID, will contribute an additional 0.8 percent, for a total of 1.6 percent, of their pensionable compensation to prefund OPEB.

Exempt and excluded employees directly tied to a bargaining unit will have their OPEB contribution rate increased based on the same phase-in schedule of the bargaining unit they have been tied to. For example, R07 employees will have their OPEB contribution increased by an additional 1.3 percent of pensionable compensation; and therefore, all S07 and M07 employees will also have their OPEB contribution increased by the same 1.3 percent of pensionable compensation on July 1, 2019.
