

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR PROPOSED
BUILDING STANDARDS

(DSA-SS/CC 02/18)
(SFM 01/18 and 06/18)**

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect-Structural Safety/Community Colleges (DSA-SS/CC) and the Office of the State Fire Marshal (SFM), is providing notice of code changes intended for the 2019 California Building Standards Code, that were the subject of written comments from the initial 45-day public comment period that was held from 9/7/18, until 5:00 PM on 10/22/18 for SFM, and from 9/14/18 until 5 PM on 10/29/18, for DSA-SS/CC.

CBSC will accept written comments for at least 15 days, between **November 2, 2018** and **November 17, 2018**. All written comments for this period must be submitted to CBSC no later than **5 p.m. on November 17, 2018** and addressed to:
