

NOTICE OF 45-DAY PUBLIC COMMENT PERIOD FOR PROPOSED BUILDING STANDARDS

OF THE CALIFORNIA BUILDING STANDARDS COMMISSION, DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, DIVISION OF THE STATE ARCHITECT – STRUCTURAL SAFETY, OFFICE OF THE STATE FIRE MARSHAL, OFFICE OF STATEWIDE HEALTH PLANNING AND DEVELOPMENT, AND THE DEPARTMENT OF WATER RESOURCES
TO CALIFORNIA CODE OF REGULATIONS, TITLE 24
(CALIFORNIA BUILDING STANDARDS CODE)

The California Building Standards Commission (CBSC), on its own behalf and that of the Department of Housing and Community Development, Division of the State Architect-Structural Safety, Office of the State Fire Marshal, Office of Statewide Health Planning and Development and the Department of Water Resources is providing notice of code changes intended for the 2016 California Building Standards Code.

CBSC will accept written comments for at least 45-days between **March 17, 2017 and May 1, 2017**. All written comments for this period must be submitted no later than 5 p.m. on May 1, 2017.
