Matters raised may be briefly discussed by the commission and/or placed on a subsequent agenda. No action may be taken by the commission on items raised during this agenda item.
- 5) **Executive Director Report:** The California Building Standards Commission Executive Director will provide an overview of current commission business.
- 6) **Office of Statewide Health Planning and Development (OSHPD EF 01/18) Emergency Building Standards Readoption:** Request to readopt emergency administrative building standards for hospital seismic safety upgrade extensions for the 2016 California Administrative Code, Part 1 of Title 24, California Code of Regulations. The Commission adopted and approved emergency administrative building standards at its January 16, 2019 meeting. The Office of Statewide Health Planning and Development is requesting a readoption of these emergency building standards for a 90-day period pursuant to [Government Code Section 11346.1\(h\)](#) so they may complete the certifying rulemaking process to make the regulations permanent. Information concerning this rulemaking package may be found at CBSC's website.
- 7) **The Department of Housing and Community Development (HCD 05/18):** Proposed adoption of the 2018 edition of the International Existing Building Code with amendments for incorporation into the 2019 California Existing Building Code, Part 10 of Title 24. The commission will take action to approve, disapprove, further study required, or approve as amended the proposed code changes. Upon adoption, these building standards will be codified and published into the 2019 California Existing Building Code, Part 10, Title 24, California Code of Regulations. Commission action will be guided by the nine point criteria established in [Health and Safety Code Section 18930](#). The commission will consider HCD's proposed building standards and its justifications, Code Advisory Committee (CAC) recommendations, comments submitted during the public comment periods and oral and/or written comment received at this meeting. The public may comment on any challenges to the proposals or CAC recommendations submitted during the comment periods. NOTE: No new issues or new information challenging the proposed code changes may be presented to the commission in the adoption of the proposed regulations. - ❖ CBSC conducts public meetings to ensure adequate opportunity for public participation and to perform a technical review of code changes pursuant to [Health and Safety Code Section 18929.1](#).
