

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR  
PROPOSED BUILDING STANDARDS FOR THE  
CALIFORNIA BUILDING STANDARDS CODE, TITLE 24,  
of the CALIFORNIA CODE OF REGULATIONS,  
DIVISION OF THE STATE ARCHITECT**

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect, is providing notice of amendment of the Initial Statement of Reasons supporting code changes intended for the 2019 California Building Standards Code, that were the subject of written comments from the initial 45-day public comment period that began on April 3, ending on May 18, 2020.

CBSC will accept written comments for at least 15 days between **May 29** and **June 13, 2020**. All written comments for this period must be submitted no later than midnight on **June 13, 2020**.
