Comment #1 Commenter: Joanne Carroll, National Association of Sewer Service Companies

Comment #1 regarding Section 715.3 Existing Sewers: The commenter expresses opposition with the existing section of model code. The recommendation is to alter the language of the code to disallow the use of cure-in-place lining to repair cast iron soil pipe.

OSHPD Response to Comment #1: The section referenced is not being modified by OSHPD in this code cycle and, therefore, is not part of this rulemaking.

DETERMINATION OF ALTERNATIVES CONSIDERED AND EFFECT ON PRIVATE PERSONS

OSHPD has determined that no alternative would be more effective in carrying out the purpose for which the regulation is proposed or would be as effective and less burdensome to affected private persons than the adopted regulation. The proposed

regulations are technical modification that will provide clarification and consistency within the code. The proposed regulations will not have a cost impact to private persons.
