The California Building Standards Commission (CBSC), on its own behalf and that of Division of the State Architect-Structural Safety/Community Colleges, Department of Housing and Community Development, Department of Water Resources, Office of the State Fire Marshal, and Office of Statewide Health Planning and Development is providing notice of code changes intended for the 2019 California Building Standards Code.

CBSC will accept written comments for at least 45 days between **September 14, 2018 and October 29, 2018**. All written comments for this period must be submitted no later than **5:00 p.m. on October 29, 2018**.
