The California Building Standards Commission (CBSC), on its own behalf and that of the Board of State and Community Corrections, California Department of Public Health, Division of the State Architect-Access Compliance, Department of Housing and Community Development and Office of the State Fire Marshal, is providing notice of code changes intended for the 2019 California Building Standards Code.

CBSC will accept written comments for at least 45 days between **September 7, 2018 and October 22, 2018**. All written comments for this period must be submitted no later than **5:00 p.m. on October 22, 2018**.
