

**COMBINED NOTICE OF 45-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS FOR THE

The California Building Standards Commission (CBSC), on behalf of the State Historical Building Safety Board and the Office of Statewide Health Planning and Development is providing notice of code changes intended for the 2022 California Building Standards Code.
