## **AGENDA ITEMS:**

### **1) Call to Order / Roll Call**

**2) Finding for a Special Meeting:** Government Code Section 11125.4(c) requires a state body to make a finding that the delay necessitated by providing notice 10 days prior to a meeting would cause a substantial hardship on the body or that immediate action is required to protect the public interest. Government Code Section 11125.4(a)(9) authorizes a state body to call a special meeting to provide for an interim executive officer of a state body upon the death, incapacity, or vacancy in the office of the executive officer. The Executive Director of CBSC stepped down on May 14, 2023, to take another position, creating a vacancy. During the May 5, 2023, Special Meeting the commission took action to recommend hiring of a Retired Annuitant as interim Executive Director. It recently came to CBSC's attention that a Retired Annuitant may not serve in an appointed position, but may serve in a different capacity. Therefore CBSC must conduct a special meeting without a full 10-day notice to discuss the hiring of a Retired Annuitant as a Special Consultant to the Acting Executive Director.

**3) Closed Session Personnel:** Presentation and discussion on selecting an interim Special Consultant to the Acting Executive Director for the California Building Standards Commission.

**4) Open Session Action taken during closed session:** Pursuant to Government Code Section 11125.2, the CBSC will report what action was taken in closed session, if any.

**5) Comments from the public on issues not on this agenda:** CBSC may receive comments from the public on matters not on the agenda. Matters raised may be briefly discussed by CBSC and/or placed on a subsequent agenda. No action may be taken by CBSC on items raised during this agenda item.

**6) Future agenda items:** CBSC may briefly discuss and set for action future agenda items related to procedural or administrative matters, substantive state building regulatory programs, or CBSC policy.
