

**NOTICE OF ADDITIONAL 15-DAY PUBLIC COMMENT PERIOD FOR  
PROPOSED BUILDING STANDARDS FOR THE

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect, is providing notice of code changes intended for the 2022 California Building Standards Code, that were the subject of written comments from the initial 45-day public comment period that began on March 10, 2023, ending on April 24, 2023.

CBSC will accept written comments for at least 15 days between **May 10 and May 25, 2023**. All written comments must be submitted to CBSC no later than midnight on **May 25, 2023**.
