

**NOTICE OF 45-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS FOR THE
CALIFORNIA BUILDING STANDARDS CODE, TITLE 24
of the CALIFORNIA CODE OF REGULATIONS
CALIFORNIA BUILDING STANDARDS COMMISSION, DIVISION OF THE STATE
ARCHITECT and DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT**

The California Building Standards Commission (CBSC), on its own behalf and that of the Division of the State Architect and the Department of Housing and Community Development, is providing notice of code changes intended for the 2022 California Building Standards Code Supplement.

CBSC will accept written comments for at least 45 days between **March 31 and May 15, 2023**. All written comments for this period must be submitted no later than midnight on **May 15, 2023**.
