

**NOTICE OF ADDITIONAL 15-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS FOR THE
CALIFORNIA BUILDING STANDARDS CODE, TITLE 24
of the CALIFORNIA CODE OF REGULATIONS
CALIFORNIA BUILDING STANDARDS COMMISSION and the

The California Building Standards Commission (CBSC), on its own behalf and that of the Division of the State Architect, is providing notice of code changes intended for the 2022 California Building Standards Code, that were the subject of written comments from the initial 45-day public comment period that began on April 21, 2023, and ended on June 5, 2023.

CBSC will accept written comments for at least 15 days between **June 15 and June 30, 2023**. All written comments must be submitted to CBSC no later than midnight on **June 30, 2023**.
