3) Proposed Emergency Standards Adoptions and Approvals: The Commission will take action on the following items to approve, disapprove, further study, or approve as amended any of the proposed code changes based on the criteria established in Health and Safety Code 18930. - a) The Division of the State Architect – (DSA EF 02/15):** These proposed building standards would add, amend and/or repeal building standards relative to water efficiency effecting a reduction in outdoor irrigation water usage relative to Chapters 1, 2, 3 and 5, California Green Building Standards Code (CALGreen), Part 11 of Title 24. This proposed emergency rulemaking is intended to supersede the emergency building standards [[DSA-SS EF-01/15](#)] approved by the Commission at its May 29, 2015, meeting .

****TELECONFERENCE INSTRUCTIONS****

All callers will begin in "Listen Only" mode.
