ACTION PLANNED BY THE COMMISSION ON BUILDING STANDARDS:

Agenda Items 4 through 6: The Finding of Emergency and proposed emergency regulations will add, amend and/or repeal building standards relative to Exterior Elevated Elements (EEE) in the 2016 edition of the California Building Code, Part 2 and the California Existing Building Code, Part 10 of Title 24. These enhanced building standards reflect amendments vetted and approved by the International Code Council for inclusion in the 2018 edition of the International Building Code (IBC) and the International Existing Building Code (IEBC). The IBC and IEBC are used as the base model code for the California Building Code and the California Existing Building Code.

All callers will begin in "Listen Only" mode.

If you wish to make a comment on a specific agenda item **please listen for the commission chair to ask for any comments from the public**.
