Agenda Item 1. CALL TO ORDER

Chair Julie Lee called the meeting of the California Building Standards Commission (CBSC) to order at 1:45 p.m. The meeting was held via Zoom and teleconference hosted by the CBSC.

Chair Julie Lee led the Commission in the Pledge of Allegiance.

Chair Lee gave instructions regarding public comments and teleconferencing.

Agenda Item 2. COMMISSIONER RE-APPOINTMENTS

Chair Julie Lee recognized the reappointment of Aaron Stockwell for a four-year term.

On January 12th, 2021, Governor Gavin Newsom reappointed Commissioner Aaron Stockwell as a public member for a four-year term.

Commissioner Aaron Stockwell took the oath and Chair Julie Lee swore him in.

Agenda Item 4. CBSC CODE ADOPTION COMMITTEE REPORT

Chair Julie Lee stated appointment of persons to the Commission's Code Advisory Committee takes place every three years. Members serve a three-year unpaid term but are reimbursed for necessary travel expenses.

The Code Advisory Committees review the technical merit of Building Standards proposed by state agencies. They provide recommendations to the Commission based upon the nine-point criteria established in Statute. Committee members appointed by the Commission represent the public, the disability community, building design professionals, the building and construction industry, local government building officials, fire officials, environmental organizations, and other affected parties.

The Commission's Code Adoption subcommittee is comprised of Commissioners Patel, Klausbruckner, Santillan, Mikiten and Sasaki. This subcommittee met on January 21st and this morning, February 18th, to select nominees for the varies positions on each Code Advisory Committee.

Commissioner Patel is the Chair for this subcommittee; he will summarize the subcommittee's recommendations for each Code Advisory Committee and share. The Commission will take action on each Code Advisory Committee affirming the nominated candidates.

Item 4a. ACCESSIBILITY (ACCESS) CODE ADVISORY COMMITTEE.

Commissioner Klausbruckner stated she reached out to Jake Tomlin as he applied for three positions, including the Fire Code Official Accessibility. His first choice was in Plumbing, Electrical, Mechanical. He was positive and agreed to be nominated for the Plumbing, Electrical, Mechanical and have the accessibility given to someone else. He's well-qualified and could be placed in any of these positions.

Chair Julie Lee turns it over to Commissioner Patel to introduce items.

Commissioner Patel notes that the subcommittee met and reviewed applications for qualifications, expertise, and interest. The letter of recommendations was also reviewed that were provided with many of the applications. Our hope was to create the broadest, most knowledgeable committee that shared the most expertise with the upcoming triennial code cycle.

For the Accessibility Committee, the subcommittee chose to limit each committee to a maximum of two Ex-Officio member nominations in order to maintain manageable and consistent number of members on each committee. Encourage all candidates not selected to please listen and participate as a member of the public.

Access Code Advisory Committee has two nominations for the Ex-Officio members. Ex-Officios for the Access Committee, 1A, Chris Adamson; 1B, Carol Bartolo Loeffler. Position 2, Disability Access Advocate, Visually Impaired, recommendation is Eugene Lozano, Jr. Position 3, Disability Access Advocate, Hearing Impaired, our recommendation is Sudhir Kumar Agrawal. Position 4, Disability Access Advocate, Mobility Impaired, our recommendation is Daniel Kaiser. Position 5, Disability Access Advocate, Cognitive Impaired, our recommendation is Bill Zellmer. Position 6, Local Government Building Official, our recommendation is Brad Wungluck. Position 7, Construction Industry, our recommendation is Michael Gibbens. Position 8, Architect, our recommendation is Jay Whisenant. Position 9, Fire Official, our recommendation is Rebecca Leda. Position 10, Public Member, our recommendation is Homer Maiel. Recommendation for Chair is Jay Whisenant.
