Agenda Item 6. EXECUTIVE DIRECTOR REPORT

Executive Director Mia Marvelli discusses the 2021 Triennial Code Cycle. The Plumbing, Mechanical, Electrical, and Energy Code (PEME) Code Advisory Committee meeting was held in March. The GREEN Code Advisory Committee is scheduled for April 28 and 29th, 2021. Remaining four code advisory committee meetings will be conducted in June, July, and August. She stated the website is up-to-date and to look for those meetings.

The Plumbing, Electrical, Mechanical Energy (PEME) 45-day comment period will begin May 28, 2021. Other comment periods are scheduled for late-August and September, and then will conclude in October and November. Upon conclusion of the comment periods, the state agencies will submit their final rule-making packages to the Building Standards Commission Staff. The Commission will then take action on the approximately 40 rule makings. Those will need to be heard in December 2021 and January 2022.

CBSC Staff coordinating with Energy Commission and filing their Notice of Proposed Action and their face sheet with the Office of Administrative Law, which will start their parts one and six, their admin code and their energy code provisions. The 45-day comment will start May 7th. The Energy Commission plans to approve their regulations in late-July. Building Standards Commission will hear them in December 2021 or January 2022.

California Energy Commission is an adopting agency. Energy Commission will receive their public comments and they will prepare materials for their Commission.

If interested in reviewing their regulations, sign up on the Energy.ca.gov website to receive meeting notices and comment period notices. BSC Staff will send it out to our stakeholders, directing them to the Energy Commission's website.

Executive Director Mia Marvelli reminds everyone that May is the International Code Council's Building Safety Month. In the past, CBSC has supported this effort. It raises awareness about building safety and reinforces the need for the adoption of model code and regularly updated building codes. It helps individuals, families and businesses understand what it takes to create safe and sustainable structures. In May, each week will be dedicated to a specific building topic. Week one will be dedicated to energy innovations. Week two is training the next generation. Week three is water safety. Week four is disaster preparedness. ICC has many tools to prompt these topics, which include educational tools for kids and community. It, also, has tools on how your jurisdiction can issue a proclamation for the month of May.
