# 4. CCDA Listening Forums – Update and Discussion

# a. Prior Listening Forums

Executive Director Dawson Rawlings stated, after the March full Commission meeting, the Commission held the its first Listening Forum of 2025 in Burlingame. The Commission partnered with the Center for Independence of Individuals with Disabilities in San Mateo County and the San Mateo Area Chamber of Commerce. The theme of the Listening Forum was what is working and what can be improved in access to businesses for customers with disabilities and how the CCDA can play a role in that.

#### b. Future Plans and Collaboration Ideas

Executive Director Dawson Rawlings stated the next Listening Forum will be regionally focused and held in Sacramento, tentatively on August 1st. Details are forthcoming.

# a. Status of 2024 Annual Report

# 6. Legislative Bill Tracking - Update and Discussion

Melerie Michael, Legislative Consultant, Office of Legislative Affairs (OLA), DGS, summarized the CCDA Legislative Status Report on the bills staff is tracking, which was included in the meeting materials.

a. Senate Bill 84: Disability access: construction-related accessibility claims: notice of violation and opportunity to correct.

This bill is identical to Assembly Bill 780. This bill is scheduled to be heard in the Senate Appropriations on May 5th.

b. Senate Bill 470: Bagley-Keene Open Meeting Act: teleconferencing.

This bill has moved from Senate Appropriations and is now on the floor.

c. Assembly Bill 649: Disability access: construction-related accessibility claim.

This bill is scheduled to be heard in the Assembly Judiciary on May 6th.

d. Assembly Bill 780: Disability access: construction-related accessibility claims: notice of violation and opportunity to correct.

This bill is in the Assembly Judiciary. It has not yet been set for hearing.

### Discussion

Committee Member Okenfuss referred to AB 649 and asked if the CCDA was able to provide subject matter expertise in the development of this bill or if staff has had discussions with the author.

Ms. Michael stated the author's office reached out to the DGS OLA early in the session requesting information about the Certified Access Specialist (CASp) Program.

# 7. CCDA Strategic Planning Conversation – Discussion

a. CCDA Strategic Planning Consultant

Executive Director Dawson Rawlings stated the CCDA's current five-year strategic plan expired on December 31, 2024. The bidding process for a new consultant recently closed. She introduced new Strategic Planning Consultant Kevin Christophe, Ph.D., Principle at Progress Consulting, and asked him to say a few words.

#### Discussion

Chair Lillibridge asked about the length of the strategic planning process.

Dr. Christophe stated the plan is to complete the strategic planning process by October of 2025.
