

Results of CCDA Commissioner Strategic Goal Survey

During July 2019, CCDA staff and strategic planning consultant, Renee Taylor developed a brief survey for commissioners to provide feedback on how well the Commission is fulfilling its strategic goals, including opportunities for improvement. Responses received will help guide discussions and planning for the Commission's revised strategic direction starting in 2020.

Nine commissioners responded to the survey, representing a 56% response rate. Commissioners who responded represent the cross-sections of the Commission's membership: five Governor appointees, one Senate appointee, one legislative member of the Assembly, and two Ex-Officios. For each question on how well the Commission is fulfilling its strategic goals on a scale of Very Poorly (1 star) to Excellent (5 stars), the most common response was "Average" (3 stars). Results for survey questions are summarized in the following tables below.
