#### California Commission on Disability Access ADA Coordinator's Survey Results

#### **Summary:**

The California Commission on Disability Access (CCDA) surveyed various state agencies and divisions in October 2017 to study each agency's ADA program and gain an understanding of the stages each program is in. CCDA received responses from 7 out of the 87 agencies contacted – which is an 8% response rate, and the survey data can only account for those agencies that responded.

- 7. Has your department implemented the California Fair Employment and Housing Act within its Human Resources program (California Government Code Section 12926 et seq.)?
