

**NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR
PROPOSED BUILDING STANDARDS**

**OF THE DIVISION OF THE STATE ARCHITECT-ACCESS COMPLIANCE
(DSA-AC) & THE DEPARTMENT OF HOUSING AND COMMUNITY
DEVELOPMENT (HCD) TO THE CALIFORNIA CODE OF REGULATIONS, TITLE 24
(CALIFORNIA BUILDING STANDARDS CODE)**

The California Building Standards Commission (CBSC), on behalf of the Division of the State Architect – Access Compliance (DSA-AC) and the Department of Housing and Community Development (HCD), is providing notice of proposed code changes intended for the 2016 California Building Standards Code.

CBSC will accept written comments concerning the notice of proposed action for at least 15-days between December 3, 2015 and December 18, 2015. All written comments for this period must be submitted no later than **5:00 p.m.** on December 18, 2015.
