# DSA Access Code Stakeholder Forum Proposed California Building Code Amendments

Monday October 24, 2022 10:00 am

This meeting will be held remotely, consistent with <u>Senate Bill 189</u>, (Committee on Budget and Fiscal Review, Chapter 48, Statutes of 2022) authorize a state body to hold public meetings through teleconferencing and to make public meetings accessible telephonically, or otherwise electronically, to all members of the public seeking to observe and to address the state body, satisfying any requirement that the state body allow members of the public to attend the meeting and offer public comment.
