BULLETIN: SUBMITTALS UTILIZING THE 2022 CALIFORNIA BUILDING STANDARDS CODE (TITLE 24, PARTS 1 THROUGH 12) PRIOR TO THE EFFECTIVE DATE

Division of the State Architect (DSA) documents referenced within this publication are available on the DSA Forms or DSA Publications webpages.

PURPOSE

The purpose of this bulletin is to announce that DSA will consider requests, on a case-by-case basis, to voluntarily utilize the 2022 California codes for projects submitted for plan review prior to the effective date of such codes. The effective date of the 2022 Title 24 codes is Jan. 1, 2023, except for the California Administrative Code (Title 24, Part 1, Chapter 4) which became effective on Mar. 5, 2022.

1. BACKGROUND

In Feb. 2022, the California Building Standards Commission (CBSC) completed the formal adoption and approval of the 2022 California Building Standards Code, which consists of the 12 parts of Title 24, California Code of Regulations, as listed below.

2. SCOPE

This bulletin applies to K-12 public schools, community colleges, and pre-check (PC) designs under the jurisdiction of DSA. For other projects under DSA jurisdiction, contact the regional manager of the DSA regional office where the project will be submitted.

The scope of this bulletin includes all parts of Title 24 except Part 2.5 (California Residential Code) including:

- Part 1 California Administrative Code
- Part 2 California Building Code
- Part 3 California Electrical Code
- Part 4 California Mechanical Code
- Part 5 California Plumbing Code
- Part 6 California Energy Code
- Part 7 VACANT
- Part 8 California Historical Building Code
- Part 9 California Fire Code
- Part 10 California Existing Building Code
- Part 11 California Green Building Standards Code
- Part 12 California Referenced Standards Code

3. EFFECTIVE DATE

The new 2022 California codes were published and made available to the public on July 1, 2022 and the effective date is Jan. 1, 2023, except the California Administrative Code (Title 24, Part 1, Chapter 4) which became effective on Mar. 5, 2022. The effective date establishes when the use of the 2022 California codes is mandatory. If an application is submitted to DSA for the

approval of plans and specifications on or after the effective date of the 2022 California codes, as established by CBSC, the project must comply with the 2022 California Codes.

4. PROCEDURE

Any requests to submit projects designed in accordance with the 2022 Title 24 codes *prior* to the effective date shall be made in writing to the DSA regional office where the project will be submitted. This request shall be signed by the design professional in general responsible charge. The corresponding DSA application must state that the project is being submitted using the 2022 California codes and a similar indication shall be placed on the title sheet of the construction documents, where the applicable codes that apply to the project are listed.

The utilization of the 2022 California codes on a *voluntary* basis will only apply to submittals to DSA between Dec. 1, 2022 and the last business day prior to the official effective date of the 2022 CBC as established by CBSC, except as noted in Section 5.3 below. Projects submitted to DSA utilizing the currently effective California Building Standards Code (2019 edition) will continue to be accepted until the last business day prior to the official effective date of the 2022 California codes.

Projects utilizing the 2022 California codes and submitted to DSA *prior* to the official effective date of such codes, may receive DSA identification stamp and signatures or otherwise be provided with written approval prior to the official effective date.

5. UTILIZATION OF THE 2022 CALIFORNIA CODES: EITHER METHOD WITHIN SECTIONS 5.1, 5.2 OR 5.3 MAY BE USED

- **5.1** Projects utilizing the 2022 California codes prior to the official effective date of such codes shall comply with *all parts* of the relevant 2022 California Building Standards Codes (Title 24, Parts 1 through 12, as listed in Section 2 of this Bulletin).
- **5.2** To use portions of the 2022 California codes in a 2019 project, projects may be submitted, reviewed, and approved to the 2019 California codes provided the design professional in responsible charge requests in writing to use portions of the 2022 California codes as an alternative design per Title 24, Part 2, Section 104.11. In this case, the portions of the 2022 California codes used must be for an entire discipline—Structural, Fire and Life Safety or Access Compliance. Mixing of 2019 and 2022 California code provisions within a portion is not allowed. When portions are used, the plans shall be denoted to be in compliance with the 2019 California codes for all disciplines.
- **5.3** For access only projects, the 2022 California code may be used at this time.

6. AVAILABILITY OF THE 2022 CALIFORNIA CODES, MODEL CODES, AND CALIFORNIA AMENDMENTS

The new 2022 California codes were published by the various model code organizations and made available to the public on or about July 1, 2022.

The 2022 California codes consist of the adopted model codes with California amendments. California amendments to the model codes are generally additions, deletions, or revisions to model code text.

Currently, the model codes are available from the respective model code organizations. The California amendments to the model codes form the 2022 California Codes.
