ALTERNATIVE DETERMINATION

DSA has determined that no alternative it considered would be more effective in carrying out the purpose for which the action was proposed; would be effective and less burdensome to affected private persons than the proposed action; or would be more cost-effective to affected private persons and equally effective in implementing the statutory policy or other provision of law.

The amendments adopted by DSA are the only regulatory provisions identified by DSA that accomplish the goal of establishing and amending provisions of the CASp program for its participants.

CHANGES MADE TO DOCUMENTS INCORPORATED BY REFERENCE – The following were changes made to the documents incorporated by reference after the initial 45-day comment period:

Form DSA 601 CASp Examination Registration (11/20/20) was revised to include existing text which was inadvertently omitted from the noticed version. These changes are non-substantive and include:

- i. A table with information on the CASp examination was added. This information provides candidates with options to register for CASp exams and includes exam costs, types, and examination locations;
- ii. A question requesting whether the candidate requires testing accommodations and a list of DSA documents required for testing accommodation requests was added.

Form DSA 602 Test Accommodation(s) Request (11/20/20) was revised with underlines to indicate proposed text for two sections to correct its initial notice as existing text. These changes are non-substantive and include:

Section 1: "D. ACKNOWLEDGEMENT

The signature must be a wet signature. Forms with electronic signatures will be returned. I certify under penalty of perjury and under the laws of the State of California that the information on this form is true and complete to the best of my knowledge. I acknowledge that any false incomplete, or incorrect statements may result in my disqualification from the certification process or denial of my request for accommodation in taking the examination."

- i. This section was initially presented without underline to indicate proposed text. These requirements are stated in existing documents incorporated by reference. The requirement for candidates to return documents with original signature and notice of return of forms with electronic signatures is stated under section III. The CASp Examination in the Certified Access Specialist Program (CASp) Examination, Certification, and Practice Standards Handbook (11/20/20).
- ii. The certify under penalty of perjury statement appears on form DSA 603 CASp Test Accommodation(s) Request Questionnaire (03/20/16). DSA proposed the repeal of this form and to combine with DSA 602; as such, this statement was relocated to DSA 602 and the underline was inadvertently omitted.
