- IR 22-4: Buckling Restrained Braces Frames: 2019 CBC This Interpretation of Regulation (IR) was revised to provide clarification of building code requirements for buckling restrained brace design, testing and inspection. (04/01/21)
- IR A-22: Construction Projects and Items Exempt from DSA Review This IR was revised to clarify when plans and specifications for alteration, reconstruction, or small new construction projects on existing public (K-12) school and community college sites are not required to be submitted to DSA for review and approval. - BU 21-01: Plan Submittal Requirements for Schools Participating in the California • Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Program This bulletin was revised to clarify the CalSHAPE Program and the requirements of local educational agencies submitting plans to DSA. (06/21/21)
- IR A-4: Geohazard Report Requirements: 2019 CBC This IR was revised to clarify the requirements for the submission of a geohazard report to the California Geological Survey (CGS) for acceptance, and subsequently to DSA, for projects within the jurisdiction of DSA. (06/11/21)

Structural Plan Filing Fee Decrease – Fee Calculator Updated

DSA structural plan review filing fees for public K–12 schools and community college projects have decreased for plans received on or after May 1, 2021. The Plan/Field Review Fee Calculator is now updated to reflect the decrease.

Project Inspector Certification Examination Schedule for 2021

Due to high demand, DSA has updated the Project Inspector Certification Examination schedule on the Apply and Maintain Project Inspector Certification webpage.

CASp Regulation Update

DSA has completed its rulemaking process to make amendments to the Certified Access Specialist Program (CASp) regulations. Revised regulations were approved by the Office of Administrative Law and are effective July 1, 2021.
