- IR A-7: Inspector Certification and Approval This publication underwent revisions to clarify the • following: only class 1 and class 2 project inspectors (PIs) may utilize the assistant inspectors (Als), class 3 and class 4 exam modifications, certification renewal requirements are referenced to DSA's Apply and Maintain Project Inspector Certification webpage, updated accepted qualifying work experience for PI project approval and additional information pertaining to the AI acceptance and approval to inspect projects. - IR A-8: Project Inspector and Assistant Inspector Duties and Performance: 2019 CAC This publication underwent revisions to clarify the following: only class 1 and class 2 may utilize the Als, PI supervision responsibilities of Als, job file document maintenance requirements of PIs, responsibilities and procedural requirements for substitute PIs, special inspection duties permitted to be performed by PIs, PI site special inspection and material testing monitoring responsibilities and additional clarification to the AI's roles and responsibilities.
