The Interagency Agreement, referred to as the "IA," between the California Department of Education and the Office of Administrative Hearings, referred to as "OAH," requires OAH to report certain information on a quarterly basis. The information included in this report is related to mediations and hearings, as well as information required by state and federal law. Where specific information in this report is identified by reference to a "task," the "task" refers to a section of the IA by section, paragraph, and subdivision of Exhibit A of the IA.

The information contained in this report for the relative quarter of fiscal year 2024-2025 reflects the current data as of July 2025.

CLOSED CASES

The data in these tables is required by Task 4.3(b) (3 and 10).

There are times when a decision is issued on expedited issues and a hearing on the remaining issues may not occur during the quarter. This may happen if the parties may reach an agreement on the remaining issues, the party that filed the case may decide to withdraw the case, the hearing may be scheduled for a date after the quarter ends, or there may be another reason. When this happens the number of cases closed because a decision was issued may not be the same as the number of hearings held, which is reported later in this report. An explanation for the difference, when there is one, will be added to explain the difference.

CASES WITH DECISIONS ISSUED THAT WERE NOT CLOSED DUE TO DECISION ISSUANCE

There was one case in the relevant quarter of the 2024-2025 fiscal year with a decision issued that was not closed due to decision issuance. There was a consolidated case in which the primary case was dismissed due to petitioner withdrawal one day prior to the start of the

due process hearing. The secondary case proceeded to hearing and a decision was issued.

Additionally, due to software limitations, one remand case was closed due to "decision issuance" but was actually a response to the district court on remand.

There were three cases in the third quarter of the 2024-2025 fiscal year with decisions issued that were not closed due to decision issuance. One dual case had an expedited decision issued during the quarter, then closed due to petitioner withdrawal following the end of the quarter. Additionally, one dual case had an expedited decision issued during the third quarter, then remained open after the end of the quarter pending the non-expedited hearing. However, the filing party failed to appear at the non-expedited hearing, so the case was closed due to inactivity in the fourth quarter. Finally, one dual case had an expedited decision issued during the third quarter, then closed due to settlement outside mediation or resolution session following the end of the quarter.

There was one case in the second quarter of the 2024-2025 fiscal year with a decision issued that was not closed due to decision issuance. One dual case had an expedited decision issued during the quarter, then remained open after the end of the quarter pending the issuance of the decision for the non-expedited hearing. Additionally, one due process hearing with mediation case was closed during the second quarter, but the decision was issued during the fourth quarter of the 2023-2024 fiscal year. This case had remained open pending ruling on a motion for sanctions. Because this case closed during the second quarter, its inclusion in the table below causes the number of cases with decisions issued that were not closed due to decision issuance to appear to be zero when it is in fact one (the dual case mentioned above).

There was one case in the first quarter of the 2024-2025 fiscal year with a decision issued that was not closed due to decision issuance. One dual case had an expedited decision issued during the quarter, then closed due to settlement outside mediation or resolution session following the end of the quarter.
