ORDER FOLLOWING PREHEARING
CONFERENCE OF FEBRUARY 6, 2015

On February 6, 2015, a telephonic prehearing conference was held before Administrative Law Judge Robert Helfand, Office of Administrative Hearings. Patricia Lewis, Attorney at Law, appeared on behalf of Student's father. Student's mother appeared on behalf of herself. Deborah R.G. Cesario, Attorney at Law, appeared on behalf of Spencer Valley Elementary District. The PHC was recorded.

Based on discussion of the parties, the ALJ issues the following order which amends the Amended Order following Prehearing Conference dated December 26, 2014:

1. Hearing Dates, Times, and Location. The hearing shall take place on February 10-12 and 17-18, 2015 at the offices of the Office of Administrative Hearings located at 1350 Front Street, Suite 3005, San Diego, CA 92101. The hearing shall continue day to day Monday through Thursday as needed at the discretion of the ALJ. The hearing shall begin at 9:30 a.m. the first day of the hearing and at 9:00 a.m. all other days unless otherwise ordered.

2. Issues. The issues to be heard are those listed in the Amended Prehearing Conference Order dated December 26, 2014.

3. Spencer Valley's request to add Anne Hensel and Tammi Dennis as expert witnesses, and strike Richard McKinney as an expert witness is granted.

4. Father's witness list is now amended to include the following: Father, Mother, Student's step-mother, Brian Duffy, Anne Hensel, Michelle Stanley, Dustin Evenson, Marc Lewkowkz, Ph.D., has been designated as an expert witness.

5. Father's motion to exclude Mother from advocating for any party in the case is DENIED. Mother is a party and has a right to fully participate in the hearing just like Father.

6. Spencer Valley's motion to exclude Father's exhibits 27 and 28 will be addressed on at the first day of hearing.

7. Father's motion to exclude certain of Spencer Valley's exhibits will be addressed on the first day of hearing.
