ORDER GRANTING REQUEST FOR CONTINUANCE AND
SETTING DATES FOR MEDIATION, PREHEARING
CONFERENCE, AND HEARING

SEPTEMBER 23, 2021

On September 22, 2021, the parties filed with the Office of Administrative Hearings, referred to as OAH, a joint request to continue this matter so that a mediation of the matter could take place.

A due process hearing must be conducted and a decision rendered within 45 days of receipt of the due process notice unless an extension is granted for good cause. (34 C.F.R. § 300.515(a) & (c) (2006); Ed. Code, §§ 56502, subd. (f), 56505, subd. (f)(3); Cal. Code Regs., tit. 1, § 1020.) As a result, continuances are disfavored. Good cause may include the unavailability of a party, counsel, or an essential witness

due to death, illness or other excusable circumstances; substitution of an attorney when the substitution is required in the interests of justice; a party's excused inability to obtain essential testimony or other material evidence despite diligent efforts; or another significant, unanticipated change in the status of the case as a result of which the case is not ready for hearing. (Ed. Code, § 56505, subd. (f)(3); Cal. Rules of Court, rule 3.1332(c).) OAH considers all relevant facts and circumstances, including the proximity of the hearing date; previous continuances or delays; the length of continuance requested; the availability of other means to address the problem giving rise to the request; prejudice to a party or witness as a result of a continuance; the impact of granting a continuance on other pending hearings; whether trial counsel is engaged in another trial; whether the parties have stipulated to a continuance; whether the interests of justice are served by the continuance or imposing conditions on the continuance; and any other relevant fact or circumstance. (Cal. Rules of Court, rule 3.1332(d).)

OAH has reviewed the request for good cause and considered all relevant facts and circumstances. The request is:

Granted. All dates are vacated. The continuance request is granted, as mediation encourages efficient use of resources by helping bring about settlements without hearing. This matter will be set as follows, according to the requests of the parties:

Mediation will be held on October 7, 2021, at 9:00 AM to 5:00 PM. The mediation will be held by videoconference. The parties are advised to completely fill out the form for future mediation requests, including the box to list a second choice date if the first date is not available, especially when the requested mediation date is close in time to the date of the request.

Prehearing Conference will be held on October 25, 2021, at 3:00 PM.

Due Process Hearing will be held on November 2, 2021 through November 4, 2021. The hearing shall begin at 9:30 AM on all days unless otherwise ordered. The hearing shall continue day to day, as needed at the discretion of the Administrative Law Judge.

The parties shall immediately notify all potential witnesses of the hearing dates, and shall subpoena witnesses if necessary, to ensure their availability to testify. Good cause for witness unavailability is not established by failing to properly notify or subpoena a witness. Prehearing conference statements and motions are due to OAH no later than three business days before the prehearing conference or with evidence of good cause why it was not possible to file the motion by that date.
