 - Non-Fi\$cal Departments Full Billing Account Number on payment/check front !!!!
 - Fi\$cal Departments Select applicable Supplier ID

- "Save As" in My Reports or Export (do not change/save to report template)
- Common CitiManager Error Messages and Resolutions
- Frequently Asked Program Administrator Questions
- Billing Account and Card Delinquencies
 - Research payment(s)
 - Verify payment posting in CitiManger
 - Ø Best Practice = Monthly from statement cycle cut (minimum)
 - If not posted, contact departmental payment unit and/or the State Controller's Office for status of check



 - A Prompt Payment incentive cannot be issued by Citibank without the Instructions form being processed through STP.
