## Revised GenAl solicitation language

"The State of California seeks to realize the potential benefits of GenAl, through the development and deployment of GenAl tools, while balancing the risks of these new technologies.

Bidder / Offeror must notify the State in writing if it: (1) intends to provide GenAl as a deliverable to the State; or (2), intends to utilize GenAl, including GenAl from third parties, to complete all or a portion of any deliverable that materially impacts: (i) functionality of a State system, (ii) risk to the State, or (iii) Contract performance. For avoidance of doubt, the term "materially impacts" shall have the meaning set forth in State Administrative Manual (SAM) § 4986.2 Definitions for GenAl.

Failure to report GenAl to the State may result in disqualification. The State reserves the right to seek any and all relief to which it may be entitled to as a result of such non-disclosure.

Upon notification by a Bidder / Offeror of GenAl as required, the State reserves the right to incorporate GenAl Special Provisions into the final contract or reject bids/offers that present an unacceptable level of risk to the State.

Government Code 11549.64 defines "Generative Artificial Intelligence (GenAl)" as an artificial intelligence system that can generate derived synthetic content, including text, images, video, and audio that emulates the structure and characteristics of the system's training data."

- STD 1000 has been eliminated
- New "materiality impacts" standard, further defined in SAM
- Duty of notification is shifted to the bidder / contractor
- If an agency receives notification of possible GenAl use, a risk assessment must be done by the agency's CIO

## GenAl contract language in GTCs

- GenAl contract language is now incorporated into the General Terms and Conditions (GTC 02/2025)
- Language is currently not in the University Terms and Conditions (UTCs), but will be added soon
- GenAl contract language not in Interagency Terms and Conditions (GIAs), only needed in interagency agreements with subcontractors
