The Office of Public School Construction (OPSC) has completed its review of Centennial High, OPSC application number 59/63529-00-016. Review of the District's project financing, expenditures, and certifications to ensure compliance pursuant to Education Code Sections 17072.35, 17074.25, and 17076.10 and School Facility Program (SFP) Regulation Section 1859.106 was conducted. In addition, the review examined the District's compliance with applicable SFP Regulations in effect when the funding application was received by OPSC, dated October 5, 2012.

The project is a non-financial hardship Career Technical Education Facilities Program project that was funded on a 50 percent State and 50 percent District basis. The project has expended funds beyond the SFP grant and is considered overspent.

OPSC has received the signed *Summary of Project Financing and Expenditures* dated June 21, 2018, from the District. As the District has concurred with the review findings in the *Summary of Project Financing and Expenditures*, the project is considered closed. Enclosed is the final report.

The District has requested a Reservation of Funds. Pursuant to Article 16, Section 1859.90.3 and Section 1859.197, the District is required to submit the California Department of Education (CDE) Plan Approval and the Division of the State Architect (DSA) approved plans and specifications within 12 months of April 15, 2015; otherwise, the apportionment will be rescinded without further Board action.

Pursuant to Section 1859.90.2, the District is required to submit a complete Form SAB 50-05 with in 90 days of receipt of CDE and DSA approved plans and specifications.

The Form SAB 50-05 submittal must contain an original signature from a designated District Representative and must be physically received by the Office of Public School Construction at 707 Third Street, West Sacramento, CA 95605 prior to the close of business on July 14, 2015.

Senate Bill 854, Chapter 28, Statutes of 2014 repealed Labor Code (LC) Section 1771.3 which required school districts to provide payment to Department of Industrial Relations (DIR) for prevailing wage monitoring. As a result, school districts awarding a construction contract on or after June 20, 2014 are not mandated to provide payment for DIR monitoring and enforcement of prevailing wage requirements. Projects with an initial public works contract awarded on or after June 20, 2014 are not eligible to receive an additional grant for prevailing wage monitoring; however, school districts are still required to notify DIR within five days of initial contract award pursuant to LC Section 1773.3(a)(1).

Pursuant to Section 1859.199, provide that the State portion of any and all project savings realized from the funding of a Career Technical Education Facilities Program project must be returned to the State.

The District shall ensure that it is in compliance with all applicable laws, regulations and certifications it made on the program forms.

Staff is requesting an adjustment to the previous unfunded approval of this project made at the December 12, 2012 SAB meeting, which included the Prevailing Wage Monitoring (PWM) grant. After a review the District does not qualify for the PWM grant. A decrease of \$533.00 is necessary for this project.

Subject: Final Plan Approval – Modernization – Career Technical Education

The California Department of Education approves the plans with the title sheet date of February 20, 2014, for the above referenced project. The plans were received on April 14, 2014. The plans meet the California Department of Education's standards for educational adequacy (California Code of Regulations, Title 5, 14001 et seq. and Education Code 17251(c) and (d)).

It is the responsibility of the school district to meet all requirements concerning toilet facilities, drinking water supply, sewage disposal, food service facilities and other plan elements having primary health and safety implications. The plans should be reviewed by the local health agency having jurisdiction and a written approval should be secured and filed in the school district's records. If the approved project involves work on an existing school building, it is the responsibility of the school district to meet all Federal, State and local requirements relating to the identification, remediation and/or removal of hazardous levels of lead and asbestos containing materials before or during construction. It is the responsibility of the district to complete all of the mitigation measures identified in the documents submitted to the California Department of Education for review.

The project as approved consists of: engineering design classroom, architectural classroom, engineering technology lab and storage.

The California Department of Education has reviewed the plans to ensure the construction project is consistent with the Career Technical Education Facilities Program application that received a score of 121. Note: while the original CTEFP stated the square footage was 2,096, the square footage of the three teaching stations equates to

5,250. The plans submitted and schematic attached to the original CTEFP application are identical.

The district has certified that this project is either exempt from, or has completed, the California Environmental Quality Act (CEQA) process.

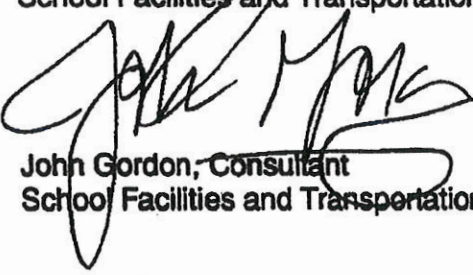

If the district is not seeking financial assistance from the State Allocation Board, the project must commence construction within two (2) years of the date of this letter. Regardless of the funding source, if, prior to construction, changes are made to the plans that would affect or alter the California Department of Education's original approval (including but not limited to changes in surrounding land uses, the master plan capacity of the project, changes in code and/or regulation, or a subsequent CEQA determination), the plan may be subject to reevaluation using the most recent standards.
