The Office of Public School Construction (OPSC) has completed its review of La Esquelita Elementary, OPSC application number 50/61259-50-002. Review of the District's project financing, expenditures, and certifications to ensure compliance pursuant to Education Code Sections 17072.35, 17074.25, and 17076.10 and School Facility Program (SFP) Regulation Section 1859.106 was conducted. In addition, the review examined the District's compliance with applicable SFP Regulations in effect when the funding application was received by OPSC, dated October 31, 2011.

The project is a non-financial hardship new construction project that was funded on a 50 percent State and 50 percent District basis. The project has expended funds beyond the SFP grant and is considered overspent.

The OPSC has identified a \$40,186.24 review adjustment for ineligible site Department of Toxic Substances Control (DTSC) and hazardous waste removal expenditures. The project overspent amount has been adjusted to reflect this finding.

The review also determined the District incurred additional eligible expenditures per SFP Regulation Sections 1859.74 and 1859.106 and may receive additional hazardous waste/materials removal, and DTSC funding in the amount of \$74.234.99.

OPSC has received the signed *Summary of Project Financing and Expenditures* (SOPFE) dated March 14, 2019 from the District. As the District has concurred with the review findings in the SOPFE, the project is considered closed. Enclosed is the final report.

Line 3 The District reported a \$18,000 abatement cost related to demolition as hazardous waste removal costs. Such costs aren't classified as hazardous waste costs, as they relate to measures to prevent toxic releases resulting from construction. They don't relate to remediation of released toxics existing prior to construction that would be required by the Department of Toxic Substances Control. The District reported \$9,468 of the amount as hazardous waste costs on project 50-61259-50-002.

The California Department of Education approves the plans with the title sheet date of August 9, 2010, for the above referenced project. The plans were received on August 16, 2011. The plans meet the California Department of Education's standards for educational adequacy (California Code of Regulations, Title 5, et seq. and Education Code 17251(c) and (d)).

It is the responsibility of the school district to meet all requirements concerning toilet facilities, drinking water supply, sewage disposal, food service facilities and other plan elements having primary health and safety implications. The plans should be reviewed by the local health agency having jurisdiction and a written approval should be secured and filed in the school district's records. If the approved project involves work on an existing school building, it is the responsibility of the school district to meet all Federal, State and local requirements relating to the identification, remediation and/or removal of hazardous levels of lead and asbestos containing materials before or during construction. It is the responsibility of the district to complete all of the mitigation measures identified in the documents submitted to the California Department of Education for review.

This letter revises and supercedes the letter issued on July 29, 2011.

The school site for this project is 2.91 usable acres. This represents 39.86% of the California Department of Education's recommended site size of 7.3 acres, as contained in the California Department of Education's "Guide to School Site Analysis and Development (2000)," for the current CBEDS enrollment of the site and the student capacity added by this project as calculated pursuant to SAB Regulation 1859.83(d).

The California Department of Education's recommended acres for the master plan capacity of the site is 7.3 acres, to be used for purposes of requesting funding from the State Allocation Board pursuant to SAB Regulations 1859.73, related to multi-story construction, and 1859.76(a)11, related to parking structures. This site is 39.86% of the California Department of Education's recommended master plan

This supercede reflects the change in usable acres for this project as a result of the district entering into a School Cleanup Agreement (SFPD 4.15) with the Department of Toxic Substance Control. The agreement encompasses the playfields and parking lot for La Escuelita Elementary which was not formally recognized in the July 29, 2011 approval letter.

The Downtown Education Complex will ultimately comprise of La Escuelita Elementary, MetWest High and a child development center on 5.53 acres.

This project removes 13 classrooms for a net gain of four teaching stations. For the purposes of funding, the project includes 9 Overcrowded Relief Grant classrooms (a total of 30,053 square feet) and 8 New Construction classrooms.

The district has certified that this project is either exempt from, or has completed, the California Environmental Quality Act (CEQA) process.

The district has met the requirement of Education Code 17213.1 and/or 17213.2 regarding preparation of a Preliminary Endangerment Assessment. The Department of Toxic Substances Control has issued a determination letter dated August 16, 2011 indicating that it has approved the draft or final cleanup plan for a response action required on this site and the district has signed a commitment to complete the response action and further investigations under a cleanup agreement with DTSC prior to occupancy.

For projects to be funded under the Leroy F. Greene School Facility Act of 1998, funding requests to the State Allocation Board must be submitted within two (2) years of the date of the initial approval letter. If the district is not seeking financial assistance from the State Allocation Board, the project

The Oakland Unified School District is requesting to use a district owned site for a school construction project pursuant to Education Code 17072.12(b) and State Allocation Board Regulation 1859.74.5.

The District has certified to the California Department of Education (CDE) that:

- 1. The district owned site located at the corner of East 10th Street and 4th Avenue is a combined four-parcel site (APNs: 019-0023-001-01, 019-0024-001-01, 019-0029-014-06 and 019-0029-014-07) totaling 5.527 acres. For the past five years, approximately 72% of this site contains buildings, such as administration offices, child care, and a fleet maintenance shop, dedicated for non K-12 school use.
- There is no available alternative district owned site for the Downtown Education Complex, which is comprised of the La Escuelita Elementary and MetWest High Schools, deemed useable for school purposes by the CDE.

The CDE has determined the following:

- The current use of 3.987 acres of the district owned site located at East 10th Street and 4th Avenue precludes the site from being otherwise available as a school site for K-12 purposes.
- 2. The district owned site located at East 10th Street and 4th Avenue is approvable by the CDE for K-12 school purposes.
- 3. The alternative site referenced in the Yovino Young appraisal, dated August 18, 2011, is approvable by the CDE for school purposes.
