ANNUAL ADJUSTMENT TO SCHOOL FACILITY PROGRAM GRANTS

PURPOSE OF REPORT

To report the annual adjustment in the School Facility Program (SFP) Grants as provided in the Education Code and Title 2 of the California Code of Regulations.

DESCRIPTION

The SFP Regulations require that various grant amounts of the SFP shall be adjusted annually based on the change in the Class B Construction Cost Index (CCI) each January. At the December 2007 State Allocation Board meeting, the Board adopted, for a one-year period, the use of the Marshall & Swift (M&S) Ten Western States CCI beginning January 1, 2008.

The M&S Ten Western States CCI increased by 3.19 percent during the period of January 1, 2007 through January 1, 2008. The figures shown on the Attachment reflect the calculated increase. The Attachment also notes the specific regulation sections. The consent items on this agenda requesting SFP funding reflect the updated grant adjustments for January 2008.

RECOMMENDATION

Approve the increase to the grant amounts as provided on the Attachment for the use of SFP applications approved on or after January 1, 2008.

This Item was approved by the State Allocation Board on January 30, 2008.
