## What are the Three Lists?

- 1. Workload List
- 2. Unfunded List (Lack of AB 55 Loans)
- 3. Applications Received Beyond Bond Authority (ARBBA) List

# Workload List – Overview

- The Workload List is a list of funding applications within available bond authority that have been submitted to OPSC to be processed to the State Allocation Board (SAB) for unfunded approval.
  - This list is composed primarily of funding applications for Modernization and New Construction.
  - Placement on this list does not guarantee funding.
- Based upon the grant amounts originally requested, it is anticipated that there is sufficient bond authority to cover the applications on this list.
  - However, how many of these projects can be funded is subject to final processing and final grant amounts of all funding applications.
  - The number of projects that can be funded is also dependent upon health and safety projects, specifically Facility Hardship or Seismic Mitigation Program projects, that are submitted since they are placed at the top of the Workload List.

# Workload List – Overview (Cont.)

- Additionally, the list contains Charter School Facilities Program (CSFP) projects that previously received a Preliminary Apportionment and have submitted a request to convert the project to a Final Apportionment. CSFP projects are funded from a bond source separate from Modernization and New Construction.
- Career Technical Education Facilities Program (CTEFP) funding applications received for the 2020 filing round are on their own workload list and funded from their own bond source.
   Placement on this list also does not guarantee funding.

# Workload List – Process

- All applications will be processed in the order prescribed in SFP Regulation Sections 1859.93 and 1859.93.1.
  - Provided that bond authority is still available, health and safety projects, specifically Facility Hardship or Seismic Mitigation Program projects, are placed at the top of the Workload List when submitted.
  - Applications for new construction and modernization will be processed in order of the received date of the application regardless of project type.
- Approximately 90 days prior to when OPSC anticipates processing an application, OPSC will notify the district of its intent to begin processing.
  - This notification advises the district that processing of the funding is nearing so that the district may prepare its staff for responding to the 15-day and four-day letters for the project.
  - The notification also requests updates to eligibility or site development requests, if they are needed.
- Eligibility applications that relate to a funding application on the Workload List will be processed with the funding application.

## Unfunded List (Lack of AB 55 Loans) -Overview

- This list includes projects that have received an "unfunded" approval by the SAB.
  - These projects have been approved by the SAB, are within bond authority, and are waiting for a bond sale in order to receive an Apportionment so that a fund release can be requested.
- This list is also commonly referred to as the "Unfunded List".
- An "unfunded" approval does not guarantee a future Apportionment by the SAB.
- Definition SFP Regulation Section 1859.2
  - "Unfunded List (Lack of AB 55 Loans)" means an information list of unfunded projects that was created due to the State's inability to provide interim financing from the Pooled Money Investment Account (AB 55 loans) to fund school construction projects as declared in the Department of Finance Budget Letter #33 issued on December 18, 2008.

# Unfunded List (Lack of AB 55 Loans) – Priority Funding Process

- The Priority Funding process was created to allow projects that are approved for placement on the Unfunded List (Lack of AB 55 Loans) by the SAB to receive an Apportionment in a timeline that aligns to bond sales, which occur twice per year.
  - Applications must first be on the Unfunded List (Lack of AB 55 Loans) to be eligible for an Apportionment.

# Unfunded List (Lack of AB 55 Loans) – Priority Funding Process (Cont.)

- SFP Regulations establish two Priority Funding filing periods per year for applicants to request an Apportionment for a project(s) on this list. Each period has a 30-day request submittal window.
  - The two Priority Funding filing periods begin on the 2<sup>nd</sup> Wednesday of May and the 2<sup>nd</sup> Wednesday of November.

# Unfunded List (Lack of AB 55 Loans) – Priority Funding Process (Cont.)

• Applicants must submit a written statement that requests to convert the unfunded approval to an Apportionment.

Request Submittal Date	Timeframe Request is Valid
During a filing period beginning with the 2 <sup>nd</sup> Wednesday of May	Valid from July 1 until December 31 of that year
During a filing period beginning with the 2 <sup>nd</sup> Wednesday of November	Valid from January 1 until June 30 of the following year

# Unfunded List (Lack of AB 55 Loans) – Priority Funding Process (Cont.)

- As bond sales take place or cash becomes available, applicants that have submitted a request for the appropriate six-month period will be eligible for Priority Funding Apportionments.
- When the applicants receives a Priority Funding Apportionment, the applicant must submit a Fund Release Authorization (Form SAB 50-05) within 90 days.

#### **Priority Funding Eligibility**

The priority funding process was created to allow projects that receive unfunded approval by the State Allocation Board (SAB) and are placed on the Unfunded List (Lack of AB 55 Loans) to receive an apportionment with accelerated timelines.

School Facility Program Regulation Section 1859.90.2 requires a school district to submit a written statement that requests to convert the unfunded approval to an Apportionment. Projects on the OPSC Workload List *cannot make this request*. Any priority funding requests received for projects on the OPSC Workload List will be returned to the district.

## Applications Received Beyond Bond Authority (ARBBA) List - Overview

- This list serves as an acknowledgment by the SAB for projects that are received by OPSC after sufficient applications were received to account for all available new construction and modernization bond authority.
- This list is also commonly referred to as the "Acknowledged List".
- Definition SFP Regulation Section 1859.2
  - "Applications Received Beyond Bond Authority List" means an informational list of applications submitted to the OPSC and presented to the Board. Funding applications placed on this list contain the preliminary grant amounts requested by a district. The OPSC has not determined that the Approved Application(s) are Ready for Apportionment."

# Applications Received Beyond Bond Authority (ARBBA) List - Background

- In November 2012 the Office of Administrative Law approved emergency regulations that impacted how OPSC processed applications received when existing bond authority is no longer available.
  - These regulations, specifically Regulation Section 1859.95.1, created the "Applications Received Beyond Bond Authority List".
- At that time, Board members opted for the Applications Received Bond Authority List system because they expressed a desire to do the following:
  - Stop processing applications for which there was no bond authority,
  - Maintain the option for changes to the program in the future, and
  - Still allow districts to submit projects (with certain conditions attached).

### Applications Received Beyond Bond Authority (ARBBA) List – Process

- Upon receipt, OPSC performs a minimal document check review of each application to ensure that no required documents are missing.
  - OPSC determines if the application includes all documents required to be submitted on the General Information section of the application, as defined in SFP Regulation Section 1859.2 as an Approved Application.
    - This means that the application submittal includes all documents that would otherwise have been submitted for an application, including approvals from the California Department of Education (CDE) and the Division of the State Architect (DSA).

## Applications Received Beyond Bond Authority (ARBBA) List – Process (Cont.)

- Pursuant to Regulation Section 1859.95.1, a District must submit a school board resolution acknowledging the following:
  - That State bond authority is insufficient for the district's funding request,
  - That a future bond may have different eligibility and funding requirements,
  - That there is no guarantee of funding, and
  - That the district's Approved Application may be returned to the District.

## Applications Received Beyond Bond Authority (ARBBA) List – Process (Cont.)

- Application packages that include all required documentation are identified as Approved Applications. These Approved Applications are then presented to the Board for acknowledgement, but not approval, and placement on the ARBBA List in order of date received.
  - The project funding amounts on the list are estimates based on requested amounts only and will likely be different if finalized.

# Applications Received Beyond Bond Authority (ARBBA) List – Current Status

- The following applications will be placed on the ARBBA List:
  - Any accepted new construction applications received on or after September 12, 2018
  - Any accepted modernization applications received on or after March 1, 2019
- As of December 3z, 2020, OPSC received the following for the ARBBA List:
  - New Construction 191 applications. Total requested -\$901,630,747
  - Modernization 504 applications. Total requested \$1,236,366,536

# Applications Received Beyond Bond Authority (ARBBA) List – Future

- The future of the current Applications Received Beyond Bond Authority List is unknown.
- The SAB will need to discuss and decide what to do with this list if/when additional bond authority becomes available.
