1.0 SCOPE

DGS Purchasing Standards provide the minimum criteria purchases must meet to be considered Environmentally Preferable (EPP), aka "green", by the state of California, to be used for incorporating requirements that meet the state's environmentally preferable goals, into procurements and policy.

Per Public Contract Code (PCC) §12400 through 12404, Environmentally Preferable Purchasing, the purchasing standard herein establishes minimum EPP requirements for Meeting & Conference Services, henceforth, Services.

2.0 APPLICABLE LAWS and INDUSTRY STANDARDS

Departments must adhere to all applicable laws, regulations, policies, best practices, and purchasing authority requirements, e.g. California Codes, California Code of Regulations, State Administrative Manual, Management Memos, and State Contracting Manual Volume 2 and 3, as applicable. This list is for informational purposes only and is not all-inclusive.

3.0 ENVIRONMENTALLY PREFERABLE PURCHASING REQUIREMENTS

Meeting and Conference Services include activities related to planning and executing meetings and conferences including but not limited to facility and lodging selection, selection of food and beverage catering, as well as the inclusion of materials and equipment utilized during the meeting. The Service, to be considered EPP, shall meet at least one of the requirements below. Items expressly used in the fulfillment of this Service should adhere to the following or certified by a third-party certification listed in Table 1:

Lodging and Conference housing facility should either:

- Housed in a LEED certified building
- A member of DGS' Green Lodging Program
- Or a Green Seal certified Hotel

Alternatively, if the facility is not partnered with one of the listed certification programs then sufficient bidder documentation should be provided to ensure the following products provided in this service meet EPP criteria:

- Paper and writing products should be certified by Forest Stewardship Council (FSC)
- Toiletry paper products should be certified by Forest Stewardship Council (FSC)
- Televisions, Monitors and all other electronic equipment should be third-party certified for energy efficiency by Energy Star or EPEAT

 Video conferencing software should be operated or serviced by an EPA Green Power Partner or Green-e certified company

As per SB 1335, products used in catering services such as food containers, dinnerware and flatware should be either:

- Certified Compostable from Biodegradable Products Institute (BPI), or
- Compliant with State Agency Buy Recycled Campaign (SABRC), containing a minimum of 30% post-consumer recycled content, such as for plastic or paper content.
