1.0 SCOPE

DGS Purchasing Standards provide the minimum criteria purchases must meet to be considered Environmentally Preferable (EPP), aka "green", by the state of California. They establish a mechanism for incorporating performance and environmental requirements that meet the state's environmentally preferable goals, into procurements and policy.

Per Public Contract Code (PCC) §12400 through 12404, Environmentally Preferable Purchasing, the purchasing standard herein establishes minimum EPP requirements for standalone office desk lamps.

2.0 APPLICABLE LAWS and INDUSTRY STANDARDS

Departments must adhere to all applicable laws, regulations, policies, best practices, and purchasing authority requirements, e.g. California Codes, California Code of Regulations, State Administrative Manual, Management Memos, and State Contracting Manual Volume F, 2, and 3, as applicable.

Products must be certified by a minimum of one corresponding Third-Party Environmental Certification program per Table 1, and/or contain a minimum of 30% Postconsumer Recycled Content (PCRC) to be considered EPP.
