### State of California Purchasing Standard Televisions

#### 1.0 SCOPE

DGS Purchasing Standards provide the minimum criteria purchases must meet to be considered Environmentally Preferable (EPP), aka "green", by the state of California. They establish a mechanism for incorporating performance and environmental requirements that meet the state's environmentally preferable goals, into procurements and policy.

Per Public Contract Code (PCC) §12400 through 12404, Environmentally Preferable Purchasing, the purchasing standard herein establishes minimum EPP requirements for televisions, henceforth, products.

### 2.0 APPLICABLE LAWS and INDUSTRY STANDARDS

Departments must adhere to all applicable laws, regulations, policies, best practices, and purchasing authority requirements, e.g. California Codes, California Code of Regulations, State Administrative Manual, Management Memos, and State Contracting Manual Volume F, 2, and 3, as applicable.

This list is for informational purposes only and is not all-inclusive. It is the state department's responsibility to ensure the purchase adheres to all applicable laws, regulations, policies, best practices, and purchasing authority requirements.

### 3.0 ENVIRONMENTALLY PREFERABLE PURCHASING REQUIREMENTS

Products must comply with the CCR, Title 20, Division 2, Chapter 4, Article 4, Appliance Efficiency Regulations and must be listed on the California Energy Commission's (CEC) Appliance Efficiency Database.

Products must be certified by a minimum of one corresponding Third- Party Environmental Certification program per Table 1and/or contain a minimum of 10% Postconsumer Recycled Content (PCRC) to be considered EPP. Metal or plastic products must contain a minimum of 10% PCRC to be considered State Agency Buy Recycled Campaign (SABRC) compliant.
