

Job Aid - How to Validate the Contracting Activity Report by using Data Validation Query (DVQ)

Target Audience: CAR Coordinator, Department Buyers, and Reporters

Purpose: After generating the Contracting Activity Report and Data Validation Query from the FI\$Cal system, departments are advised to check the validity of the report. The Data Validation Query has the detailed information of the transaction behind the Contracting Activity Report numbers. This Job Aid provides a step-by-step explanation of how the department users can validate their CAR report. The Data Validation Query (DVQ) applies to the Contracting Activity Report, SB-DVBE Options and DVBE Incentive Report. The system will generate a separate DVQ for IBond/IIJA report. The DVQ is not to validate the Consulting Services Report or the ERGSO Report.

Here are the definitions for the column headers in the Data Validation Query Report:

Transaction ID (TID-XXXXX....)	Transaction number of the Contract, PO, SCPRS, and PCard. The Transaction Id will begin with 'TID - '.
Employee# (PCard only)	Employee's' ID number
Employee Name (PCard only)	Employee's' name
Transaction Status	Status of the transactions. e.g., Approved, complete, etc..
FY Latest Change Order Approved	The fiscal year selected on the reason code page in the latest amendment
Buyer ID	Buyer identification number.
Buyer Name	Name of buyer
Contract/PO Ref #	A contract and PO free form field in the contract/ PO header.
Term Start Date	Transaction Start Date / Approved Date / Amended Date.
Term End Date	Transaction end date.

Contract/PO Association	Shows if the transaction is a Departmental Contract and a PO with no contract association. If the PO is associated with a Contract, the cell displays blank. Shows LPA, If PO is associated with LPA.
CAR Reportable?	'Yes' or 'No' selection on the transaction.
Form 810 Reportable Category	Category (mainly based on the Acquisition type) for which the CAR reportable amounts are reported.
Acquisition Type	Acquisition type selected on the transaction.
Acquisition Sub Type	Acquisition sub type selected on the transaction. This field is optional except for Non-IT Services.
Acquisition Method	Acquisition method selected on the transaction.
Total Transaction Amount \$	Total amount entered on the procurement transaction.
State Funded %	Percentage entered in the transaction. Enter the value if known. If the field is left blank the system uses 100% in the calculation.
Bidder/Supplier ID	Bidder or supplier number.
Bidder/Supplier Name	Bidder or supplier name.
Certification ID	Certification identification number
Prime	Yes or No denotes if the supplier is the prime.
Sub	Yes or No denotes if the supplier is the sub.
SB%	Percentage of the SB on the Sub-contracting page.
MB%	Percentage of the MB on the Sub-contracting page.
DVBE%	Percentage of the DVBE on the Sub-contracting page.
SB-PW%	Percentage of the SB-PW on the Sub-contracting page.
NVSA%	Percentage of the NVSA on the Sub-contracting page.
CAR Reportable Amount \$	The amount included in the report after applying the CAR reportable logic. Here are examples of some of the logic / rules: <ul style="list-style-type: none"> - Transaction must be within the reporting period - CAR reportable should be "Yes" - Total amount is multiplied by the % state fund - Amendment / change order only includes the incremental amount and is reported on the fiscal year that the change occurred
SB Reported Amount \$	The dollars awarded to the Small Business prime and the sub.
MB Reported Amount \$	The dollars awarded to the Micro Business prime and the sub.
DVBE Reported Amount \$	The dollars awarded to the Disabled Veterans Business Enterprise prime and the sub.
Exempt from DVBE Incentive?	Identifies if the transaction is exempted from the DVBE Incentive reporting.
DVBE Incentive Reported? Amt \$	The dollars awarded by using the DVBE Incentive.

SB Option Reported Amount \$	The dollars awarded by using either the SB Option or Public Works SB Option as an acquisition method.
DVBE Option Reported Amount \$	The dollars awarded by using either the DVBE Option or Public Works DVBE Option as an acquisition method.
IBond/IIJA Number	IBond/IIJA selected on procurement module
IBond/IIJA Description	Description of IBond/IIJA selected on procurement module
Exempt from SB Goal-IIJA only	Shows if the Exempt from SB Goal-IIJA only check box checked or not. N- no check and Y- checked
Statewide Incident ID	Statewide Incident ID entered on the transaction
Statewide Incident Description	Statewide Incident description entered on the transaction
Mission Task ID	Mission Task ID entered on the transaction
Mission Task Description	Mission Task Description entered on the transaction

Notes: The system will generate a separate DVQ with the Form 810 A report named “The Form 810 A IBond_IIJA – Data Validation Report” with the same columns as in the “Form 810 CAR - Data Validation Query”. The Form 810 A DVQ will calculate IBond/IIJA Reported \$ not the CAR Reported Amount \$.

IBond/IIJA Reported \$	The amount included in the Form 810 A report after applying the reportable logic. Here are examples of some of the logic / rules: <ul style="list-style-type: none"> - Transaction must be within the reporting period. - Exempt from SB Goal-IIJA only check box should not be checked.

d) Copy the Transaction ID column and DVBE Reported Amount column open a new sheet and paste the copied columns.

e) Select the copied Transaction ID and DVBE Reported Amount columns then select *Data* from the quick access toolbar at the top of the Excel sheet and click *Remove Duplicates*.

f) Count the number of Transaction IDs after removing the duplicates.
