STATUTORY AND REGULATORY REQUIREMENTS

- ► Military and Veterans Code Section 999.5(d)
- ► Government Code Section 14841
- ► Code of Regulations Section 1896.78(e)
- ► State Contracting Manual (SCM) Section 8.16(c) Volume 2,3,F-Chapters 3 & 12

Upon completion of the contract, the awarding department shall require the prime contractor to certify, in detail, information regarding payments to the DVBE(s).



AUTHORITY - STATUTES

MVC 999.5

- (d) Upon completion of an awarded contract for which a commitment to achieve a disabled veteran business enterprise goal was made, an awarding department shall require the prime contractor that entered into a subcontract with a disabled veteran business enterprise to certify to the awarding department all of the following:
- (1) The total amount the prime contractor received under the contract.
- (2) The name and address of the disabled veteran business enterprise that participated in the performance of the contract.
- (3) The amount and percentage of the work the prime contractor committed to one or more disabled veteran business enterprises under the requirements of the contract and the amount each disabled veteran business enterprise received from the prime contractor.
- (4) That all payments under the contract have been made to the disabled veteran business enterprise. Upon request by the awarding department, the prime contractor shall provide proof of payment for the work.



DVBE SUBCONTRACTING REPORTS

PRIME CONTRACTOR DVBE SUBCONTRACTING REPORT Form DGS PD 810P

Prime contractor to submit to the awarding department upon completion of a contract on which DVBE subcontracting was used/committed

DEPARTMENT DVBE SUBCONTRACTING REPORT

Form DGS PD 810D

Department to submit to DGS each November 1st the consolidation of all the prime contractor's DVBE subcontracting reports received for the fiscal year.

PRIME CONTRACTOR'S REPORT DGS PD 810P

- Captures DVBE subcontracting information
- > ONLY one contract per form
- Includes all DVBE firms that performed an element of the work on this contract.
- Departments fill out prior to emailing to the prime contractor
 - * Contract Number

* Prime Contractor Name, Address

- * Department Information
- * Date Contract Completed
- * Contract Award Amount
- * All listed DVBE Subcontractors' Name, address and Certification Number
- * Total Contracted Amount to Each Listed DVBE



PRIME CONTRACTOR'S REPORT DGS PD 810P

- Multi-Year Contracts due at the end of the contract (not every year).
- ✓ On Statewide Contracts, information on DVBE is reported by prime contractors directly to DGS PD, not awarding departments.
- ✓ Awarding departments must ensure receipt of the report from the prime contractor within 60 days from the issuance of the final payment.

Per AB 1365, departments retain ALL DGS PD 810P and supporting information reported in their procurement and reporting files for 6 years.

- All information for this report is captured from the Prime Contractors' Reports (Form DGS PD 810P)
- All contracts and POs with DVBE subcontracting completed within the reporting Fiscal Year for which you received an 810P.
- Prime contractor reports received after the department's submission to OSDS shall be included in the next fiscal year report.
- > Include contracts issued by DGS or any other department on behalf of your department, except statewide contracts.

NOTES:

- > Each line represents ONE prime contractor's report.
- > Additional lines are available on separate tabs.
- > The grand total is calculated on the first tab.
- > Blue cells are calculation cells and are locked from editing.
- > NEW! Enter the total Number of Contracts with DVBE subcontractors completed during the fiscal year.
- > NEW! No longer on legal sized paper or format.
- > NEW! Supports electronic signature.

REPORTING REQUIRED!

- > All Agencies/Departments must report.
- ➤ If an Agency/Department does not believe they should report, they must show the specific statute demonstrating they are exempt from reporting.
- ▶ If you did not receive any DGS PD 810Ps from prime contractors, fill out the 810D including the total number of contracts completed during the fiscal year, state "Nothing to Report" and submit.
- > If no contracts were completed during the fiscal year, enter 0 in the number of contracts completed field.

DVBE Subcontracting Report and DVBE Program Compliance



COMPLIANCE MEASURES

- > AB 230 (effective January 2020)
 - Added Public Contract Code Section 10230 regarding notification to contractors
 - Strengthen Military and Veterans Code Section 999.5 regarding DVBE subcontractor use
- System Generated Subcontract notifications in Fi\$Cal (effective May 2020)
- SB 588 (effective January 2021)
 - Added withholding until DVBE subcontract use has been certified.
- Important actions moving forward
 - OSDS to use of DVBE Subcontracting Reports as a tool to identify prime contractors not utilizing subcontractors.



AUTHORITY - STATUTES

NEW MVC 999.7

(a) The awarding department shall withhold, on a contract entered into on or after January 1, 2021, ten thousand dollars (\$10,000) from the final payment, or the full final payment if less than ten thousand dollars (\$10,000), until a prime contractor complies with the certification requirements of subdivision (d) of Section 999.5. A prime contractor that fails to comply with the certification requirement shall, after notice, be allowed to cure the defect. Notwithstanding any other law, if, after at least 15 calendar days but not more than 30 calendar days from the date of notice, the prime contractor refuses to comply with the certification requirements, the awarding department shall permanently deduct ten thousand dollars (\$10,000) from the final payment, or the full payment if less than ten thousand dollars (\$10,000). For contracts awarded for use by multiple state agencies, the Department of General Services may prescribe additional or alternative mechanisms for enforcing the certification requirement.



STATUTORY AND REGULATORY REQUIREMENTS

NEW SB 588 added Military and Veterans Code Section 999.7

- On contracts entered into on or after January 1, 2021
- Awarding departments shall withhold \$10,000 from the final payment, or the full final payment if less than \$10,000
- Until the prime contractor complies with the certification requirements of section 999.5 of the Military and Veterans Code.

If the prime contractor fails to comply with the certification requirements:

- > The awarding department shall give notice to the prime contractor of the requirement
- > The prime will be allowed to cure the defect
- However, after at least 15 calendar days but no more than 30 calendar days from the notice, the prime contractor fails to provide certification, the awarding department shall permanently deduct \$10,000 from the final payment or the full payment if less than \$10,000
