The Department of General Services (DGS) proposes to revise the California Code of Regulations (CCR), Title 2, Division 2, Chapter 3 Sections 1896.60 et seq. This CCR is also known as the Disabled Veteran Business Enterprise (DVBE) regulations. The revisions will incorporate:

- Legislation chaptered in years 2003 through 2010, and
- Organize the DVBE regulations to correspond to the Small Business regulations
