RE: Fiscal Year 2015/16 Deadlines for Receipt of Purchase Estimates (PE), Non-Competitively Bid (NCB) Contract Justifications, Limit to Brand or Trade Name (LTB) Statements, and Special Category NCB Requests (SCR)

The Department of General Services, Procurement Division (DGS-PD) is alerting all state departments that the Fiscal Year 2015/16 deadline dates for receipt of Purchase Estimates (PE), Non- Competitively Bid (NCB) Contract Justifications, Limit to Brand or Trade Name (LTB) Statements, and Special Category NCB Requests (SCR) are approaching. Due dates noted herein must be met for DGS to process your request. Failure to meet the due dates can result in DGS denying the request.

Departments should be aware that requests for some commodities must first be approved by offices or agencies before being submitted to DGS (e.g., DGS Office of Fleet and Asset Management, DGS Real Estate Services Division, Department of Technology, California Prison Industry Authority, or the Department of Finance). Departments must obtain such approvals prior to submitting requests to DGS.

If your department has purchasing authority to conduct procurements, please remember that some procurements require prior approval by DGS/PD of the NCB, SCR, and LTB; submittal of these documents to the DGS for review and approval must occur prior to the dates noted herein.
