**Update on the 2015 Small Business Rulemaking Efforts**

The Department of General Services (DGS), Procurement Division, Office of Small Business and Disabled Veteran Business Enterprise Services (OSDS) is providing this update to California Code of Regulations (CCR), Title 2, Division 2, Chapter 3, Subchapter 8, Office of Small Business Procurement and Contracts, Sections 1896 – 1896.22, rulemaking in progress. The above referencing section of CCR is also commonly known as the Small Business (SB) regulations. These regulations were reevaluated throughout 2015, including publication of proposed changes, a public comment period and incorporation of revisions based on the input of stakeholders specifically affected. Having the benefit of these contributions and with the acquisition of additional expertise with respect to technical aspects of rulemaking, OSDS is pleased to announce that this rulemaking initiative will continue in the upcoming year, with renewed momentum.

**Scope of 2016 Rulemaking Efforts**

Additions, deletions, consolidations and incorporation of previously chaptered legislation, as well as Assembly Bill 413 (Chapter 513, Statute of 2015) provisions concerning disabled veterans' survivor status, will be included. OSDS will publish and distribute a new Administrative Procedure Act (APA) compliant rulemaking proposal in late spring, encompassing changes in existing regulations, opening a public comment period and setting a public hearing date.

Recommendations, comments and testimony received during the 2015 public comment phase will have already been incorporated in the content of the 2016 package. A 45-day public comment period will follow, and after considering all timely and relevant suggestions, the 2016 regulatory proposal may be adopted. Should any substantive changes be

incorporated on the basis of public comment, another review period will be announced before final adoption of any change in existing rules. It is DGS' expectation that the APA rulemaking adoption steps will be completed by this upcoming fall.
