- RE: Notice of Proposed Rulemaking affecting Certified Small Business and Disabled Veteran Business Enterprise Regulations (including a 45-day public comment period and public hearing date).

The Department of General Services (DGS), Procurement Division, Office of Small Business and Disabled Veteran Business Enterprise Services (OSDS), proposes revisions to the California Code of Regulations (CCR), Title 2, Division 2, Chapter 3, Subchapter 8, Office of Small Business Procurement and Contracts, Sections 1896 – 1896.22, Subchapter 10.5, Disabled Veteran Business Enterprise Participation Goal Program for State Contracts and Subchapter 10.6, Disabled Veteran Business Enterprise Incentives, Sections 1896.99.100 – 1896.99.120. These rules are commonly referred to as the Small Business (SB) and Disabled Veteran Business Enterprise (DVBE) regulations, and incorporate the following chaptered legislation:

- Chapter 756, Statutes of 2021, Assembly Bill 1574 (Sections 9 and 15 only)
- Chapter 80, Statutes of 2020, Senate Bill 588
- Chapter 676, Statutes of 2019, Assembly Bill 230
- Chapter 689, Statutes of 2019, Assembly Bill 1365

Furthermore, in line with Government Code section 14836, SB regulations revisions include the addition of a new section 1896.5, Small Business Participation Goals, to notify state departments of their ability to develop contract-specific participation requirements in order to support their participation and meet the overall SB participation goal.

An accompanying Initial Statement of Reasons (ISOR) explains, in detail, the changes proposed and provides reasons why they are being contemplated. The current and proposed SB and DVBE regulation text, Notice of Proposed Rulemaking and the ISOR are available at the following DGS web page:

A 45-day public review period opens on September 2, 2022, at 8:00 a.m., and ends on October 17, 2022, at 11:59 p.m. Comments on the draft regulations and submissions by interested persons or their authorized representatives will be accepted during this time. The DGS will consider only those comments received during the public review period specified above.
