Contracting Activity Report (CAR) New Due Date is October 1

Purpose

The purpose of this broadcast bulletin is to announce the Contracting Activity Report (CAR) due date has permanently changed from August 1 to October 1.

Policy

Public Contract Code Section 10111 requires the Department of General Services (DGS) to prepare an annual report containing specific contracting activity data. Prior years required state departments to collect and report the required data to the DGS by August 1st of each year. The State Contracting Manual (SCM) policy for the CAR due date has permanently changed to October 1.

When October 1 falls on a Saturday or Sunday, the due date will be the Monday immediately following October 1.

Background

In 2019, the Contracting Activity Report (CAR) was implemented in the Financial Information System for California (FI\$Cal). Departments transacting in FI\$Cal rely on FI\$Cal's timelines and processes to capture reportable CAR transactions. For fiscal years 2018-19 and 2019-20, departments had to either ask for extensions or submit a paper report because they could not meet the August 1 due date which created additional work for both DGS and reporting departments. For fiscal year 2020-21, a one-time due date extension was granted from August 1, 2021, to October 31, 2021.

Effective 2022, the new due date, October 1, will provide additional time for state departments to capture all reportable transactions, including emergency procurements.

Procedure

OSDS will generate the report one day after the October 1 due date.

There is no change in procedure for departments that transact in FI\$Cal. The CAR report will generate directly from FI\$Cal.

Departments transacting in FI\$Cal should generate reports through the system for their records.
