Tuesday, August 15, 2023 1:30 p.m. to 2:30 p.m.

1. Welcome

Nick DeAngelis, Purchasing Authority Unit (PAU) Supervisor, Department of General Services (DGS), Procurement Division (PD)

Nick DeAngelis welcomed all participants and provided instructions on participating in the Purchasing Authority Round Table (PART) meeting. As the meeting is being held through Microsoft Teams (MT) remotely, participants were instructed to mute microphones to minimize background noise. For questions, participants are to utilize the MT meeting hand feature or enter questions in the MT chat. Opportunities to ask questions will be provided at the end of each speaker's presentation and the end of the PART meeting.

2. Procurement Division and Policy Updates Sarah Cering, PT&CS Branch Chief, DGS, PD

DGS 60th Anniversary Event

- Event planning is underway the event is scheduled for October 2023
- Events will include Procurement Division hiring recruitment and new PD services offered.

One-Time Acquisitions (OTA)

- Record high requests received in OTA last fiscal year.
- Non-IT procurement requests are still in progress through September 28.

Dispute Resolution Unit (DRU)

- Record high requests received for protests and Public Records Act (PRA)
- PRAs exceeded the 200 per-year average.
- Re-organization into two units
 - Non-Competitive Bids (NCB), Special Category Request (SCR) and Limited to Brand (LTB) Unit
 - o TACPA, PRA, Disputes and Protests Unit
 - o Two open supervisory positions for these units
 - Staff Services Manager I (SSM I) for TACPA, PRA, Disputes and Protests Unit
 - IT Supervisor for the NCB, SCR, and LTB Unit
 - SSM I and IT Supervisor vacancy announcements are currently closed.
- TACPA

- Outreach development/Implementations per Executive Orders and enacted 2022 Legislative Bills underway.
- o Increase in TACPA applications received over past fiscal years.

Non-Competitive Bids (NCB)

- Record high NCB requests this FY end.
 - o Minimal resources have been impacting processing timelines.
- NCB process improvements
 - DGS and the California Department of Technology (CDT) collaborated on IT Project Authority assessment to reduce back and forth communication between CDT and state agencies.

Contract Classification Quick Guide

- Combines State Administrative Manual (SAM) and existing State Contracting Manual (SCM) policy on contract classifications.
- Provides state agency procurement programs a reference guide for classifying procurements for various acquisition methods.
- Feedback request sent to the PART focus group with a due date response of August 18, 2023.
- Broadcast Bulletin will announce the Contract Classification Quick Guide and provide the website link location once the guide is finalized.

3. OSDS Updates

Count of Certified Firms as of July 2023

- 17.974 SB
 - o 15,449 SB (Micro)
 - o 2,474 SB
- 3,950 SB (Public Works)
- 1,852 DVBE (includes dual SB and DVBE/triples SB, MB, and DVBE)

OSDS Certification Backlog

- Certification staff are continuing to work processing certification requests.
- Revisions to OSDS internal certification procedures are currently in progress to improve certification processing times.

Small Business/DVBE Compliance

- Open recruitment for a manager and staff in the SB/DVBE Compliance Program.
- Eighteen (18) program abuse cases are currently under evaluation.

• Eleven (11) compliance investigations are currently under evaluation.

Small Business and DVBE Regulations

- Revised SB/DVBE regulations became effective June 29, 2023.
 - o Incorporates AB 1574, SB 588, AB 230, and AB 1365.
 - Appreciation was given to Sarah Cering's staff who assisted with SB/DVBE regulation revisions.
- Section 1896.5 Small Business Participation Goals added to the SB regulations.
 - Added to meet and exceed state departments' 25% SB participation goals.
 - Requires departments to implement procedures and expand their pool of SB and DVBE bidders.
 - o Includes explicit authority for departments to set contract specific SB participation goals and to establish appropriate SB participation requirements.
 - o Describes the determining factors for setting SB participation goals.
 - o Includes the potential bidders' requirements to qualify as responsive bidders on contracts with SB participation.
