Subject: Notice of Availability of a Draft Environmental Impact Report for the CDFA Turlock North Valley Laboratory Replacement Project in Turlock, California (SCH #2021020514)

To: Interested Parties

1. NOTICE IS HEREBY GIVEN that the California Department of Food and Agriculture (CDFA), with assistance from the Department of General Services – Real Estate Services Division (DGS), is the lead agency for preparation of a draft Environmental Impact Report (DEIR) pursuant to the California Environmental Quality Act (CEQA) for construction and operation of the CDFA Turlock North Valley Laboratory Replacement Project (Proposed Project). This DEIR was prepared in compliance with the California Environmental Quality Act (CEQA) of 1970 (as amended) and the CEQA Guidelines (California Code of Regulations [CCR] title 14, section 15000 et seq.). CDFA hereby invites comments on the adequacy and completeness of the environmental analyses in the DEIR.

5. **Project Location:** Site consists of an approximately 7.5-acre portion of a 27-acre parcel located at 830 Dianne Drive in the City of Turlock, Stanislaus County. The site is situated at the northeast corner of Dianne Drive and West Canal Drive, directly west of Highway 99.

6. **General Plan Designation:** Office
7. **Zoning:** Office Commercial

8. **Brief Description of the Proposed Project:** The CDFA's proposed Turlock North Valley Laboratory Replacement Project (Proposed Project) would relocate the existing California Health and Food Safety (CAHFS) Turlock Laboratory to a new site and facility with adequate space for necropsy, laboratory, and office functions to provide full services to the livestock and poultry farmers in the region, and consolidate two Animal Health and Food Safety Services (AHFSS) field offices to a central location. The Proposed Project would provide adequate workspace, equipment storage, and vehicle parking for approximately 44 current employees assigned to this office, increasing to 56 employees in the future. Proposed facilities would include a laboratory building, cremator, access driveway, truck rinse pit, parking areas, an emergency generator, and other utility and ancillary improvements.
9. **Environmental Review:** The DEIR evaluates the potential environmental impacts of the Proposed Project and two project alternatives: the Nunes Road Site Alternative (CDFA would construct and operate a replacement laboratory facility similar to the Proposed Project on a 10-acre property at Nunes Road and North Golden State Boulevard in Keyes, California); and the Reduced Project Alternative (only CAHFS facilities would be relocated to the site, reducing total staffing to 29 employees and reducing total acreage by approximately 0.72 acre). A No Project Alternative was also evaluated (CDFA would not construct a new CAHFS Turlock North Valley Laboratory or consolidate two AHFSS offices to a central location, and would continue to provide services to the North Valley area from the three existing facilities in Turlock, Modesto, and Stockton). Six CEQA resource topics and individual significance criteria in several environmental resource topics have been eliminated from further analysis in the EIR based on the nature and scope of the Proposed Project activities. A brief summary and description of each of these resource topics and significance criteria is provided in Chapter 3, *Introduction to the Environmental Analysis*. A full analysis of these dismissed resource topics and significance criteria are provided in the Initial Study, included in Appendix A, *Scoping Summary*.
10. **Hazardous Materials:** The Proposed Project is not located on the lists enumerated under Section 65962.5 of the Government Code, including, but not limited to, lists of hazardous waste facilities.
