Given this proposed four-year rule, extensions no longer apply which also alleviates an unnecessary administrative burden. With the removal of extensions, it is necessary to add an exception permitting DSA to withdraw approval or institute post-approval requirements as necessary to address life-safety concerns in response to information received after approval of plans and before commencement of construction.	Approve
